Chairman's Annual Report for 2021

This has been another very difficult year for our villages, like the rest of the country. It has been hard for our residents, many of whom have been shielding and increasingly isolated. The stop-start of lockdowns has been very frustrating. However, with the gradual relaxation of restrictions we have been able to reopen some services. Our Committee and volunteers have been incredibly inventive and determined, doing their best to keep up contact and support.

I want to pay tribute to the sterling efforts of Christine Lindsay and her group of volunteer drivers who have kept our community transport going throughout. This took a great deal of work on keeping safe and a degree of courage too on the part of those who used their own cars. It was even more remarkable, as most other local such services closed for the duration. Visits to hospitals and Pulborough Medical Group were added to by vaccination runs, thereby saving the doctors home visits.

The Lunch Club and Wednesday Club joined forces, and reopened in September, which was hugely welcomed. Congratulations to Louise Kaiser, with continued support from Ann Kaiser for the lunches. Thanks also to Rosemary Russell, Liz Sollom and Gerald Batt for the morning Club continuing.

Sadly, we have lost other clubs and services such as Tai Chi and Toenail Cutting, as the people running them had to move on. However, over the past month or so we have been working on an exciting new development. Along with Freddie Jones, the Social Prescriber in the Pulborough Medical Group, we have been planning to open a new Befriending/Visiting Service, which is much needed given the very high levels of isolation and loneliness which are recorded in Pulborough. We hope to get this going in the early summer.

We are also very pleased that the Wednesday Club is to be joined by a Thursday club to be run by our friends in the Baptist Church, and so offering residents an additional opportunity to get out.

We are finally able to have face to face Committee meetings again, which is most encouraging.

Financially we have managed to keep going through reserves and continued support from the Councils. We are also grateful to Pulborough Medical Group who have restored our grant in part. This had been negotiated based on our supporting so many of their patients (we cover the same area as the practice does), including preventing the need for some home visits and taking older people in to be vaccinated.

In this so difficult year I want to give heartfelt thanks to all the Committee, the Trustees and our Honorary President Jean Seagrim. Thanks indeed to Alan Sugarman as our Treasurer and to Hannah-Louise O'Callaghan as our Secretary. This year at the AGM we have several people stepping down after many years of service on the Committee, though they are all saying they will continue to help out. So, we are losing Ann Kaiser, Rosemary Russell, Liz Sollom, Sheila Moore, and Gerald Batt.

Trustees Report for 2021

The Association is governed by its Constitution which was adopted on 22 nd July 1985 and amended on 7th October 1991, 31st March 2003, 13th March 2013 and latterly on 23rd March 2015.

Our objects are:

- a) To promote the benefit of the elderly inhabitants of the area of benefit in any manner which is now or hereafter may be deemed to be charitable in law, and
- b) To relieve persons resident in the area of benefit who are in conditions of need, hardship or distress and to coordinate similar work undertaken in the said area by other voluntary organisations.

Trustees are appointed by the Committee and hold office for life or until discharged at their own request or by the Committee by resolution. Our honorary President, Jean Seagrim, who was also our co-founder, was appointed in March 2017.

Our activities during the year are reported on by their organisers elsewhere in this report.

Much of our funding is from local authorities, but we have funding from generous local organisations and from individuals who support what we do. We maintain a prudent level of reserves, given the current difficult economic climate and the uncertainty of a revenue stream.

As we were still in a national lockdown for the first part of 2021 we continued with our correspondence with our members. The Wednesday club leaders made regular phone calls to all our members, weekly to those living alone and the lunch club leaders posted a parish magazine, newsletters, and quizzes monthly. All our members really appreciated the continued contact and support.

We used a bequest from Joyce Smith, a long-standing member, to give a Fairtrade Easter Egg or Chocolate Chicken to all Lunch and Wednesday Club members.

The Wednesday Club leaders had decided to step down at the end of 2021 after running the club for 12 years. Therefore, it was decided to combine the two clubs, offering a slightly different format and a 3-week trial was carried out in July 2021. The new format consisted of a social time from 11.30-12.30, followed by lunch. The social time included activities such as board games, musical entertainment, and gentle exercises. This new style club has been well received by most of our members.

From September 2021 we reopened the club and have had good attendance each week. We have also welcomed four new members. Sadly, we lost some members throughout the year, some have moved into nursing homes, and some have lost the confidence to socialise.

In December we had our Christmas lunch and thanks to donations were able to give all our members, volunteers, and guests a complimentary lunch. Thanks to a generous bequest from one of our long-time members, Iris Gravett, we were able to give all our members and volunteers a Christmas gift of a planted hyacinth and fairtrade chocolates. We also said a big 'thank-you' to the Wednesday Club leaders for their years of service.

During the year, 405 journeys were made to take 95 passengers to various medical appointments. Of the 95 passengers, 20 of them specifically needed the Blue Angel and made 50 journeys between them.

60 of the 95 passengers live in Pulborough, 15 in West Chiltington, 4 in Bury, 3 in Nutbourne, 3 in Bignor, 2 in Coldwaltham, 2 in Storrington, 2 in Fittleworth and one in each of Cootham and Watersfield.

Destinations included: St. Richard's Hospital, Worthing Hospital, Bognor Regis War Memorial Hospital, Southlands Hospital (Shoreham) Royal Sussex at Brighton, Q&A at Portsmouth, Princess Royal in Haywards Heath, Royal Surrey in Guildford and The Nuffield Hospital in Chichester.

More locally, many journeys were made to: The Pulborough Medical Group, Ken Hall's (dentist), The Dental Centre in Lower Street, Donovan's (dentist) in Petworth, Andrew Jenkins (podiatrist) in Storrington and to a physiotherapy centre in Storrington.

At the moment, we are meeting most requests for transport, providing the necessary 48 hours notice period is adhered to. However, the number of available drivers is falling and it is going to be difficult to meet as many requests in the future without more drivers coming forward to volunteer. We are launching an active "recruitment campaign" and hopefully a few more drivers will come forward so that we can continue to meet demand from passengers.

Treasurer's Report on the 2021 Accounts

Although, for yet another year, our activities have been severely reduced by the pandemic, Pulborough Community Transport has continued throughout, the Lunch Club has restarted, and consideration is being given to a reformatted Wednesday Club. These activities all incur costs.

The Association received very generous, and very welcome, grants from The National Lottery and The Ernest Kleinwort Charitable Trust. We also benefitted from support from Pulborough and West Chiltington Parish Councils and Pulborough Medical Group, albeit at a lower level than in the past in some cases, but our costs still exceeded our income by more than £5K. This is unsustainable in the long run, and we can only hope that at some stage the local community will be in a position to offer more support.

How we are funded: The Pulborough & District Community Care Association is a registered charity.
