Chairman's Annual Report for 2019

This year has seen our services continue to develop sustainably, and ever more people in our community have both helped and been helped. This has also been supported by better co-ordination of local services, as we have long advocated, with a valuable initiative by Horsham District Council.

You can see from the full annual report how each service has developed during the year, but I wanted to highlight some key themes, both in our services and across the board.

Community Transport has always been a significant part of our work and funding, and it has continued to develop, with Christine Lindsay building strongly on the work carried out by Mike Clenshaw. The number of journeys supporting vulnerable people has been over a thousand, and this year there have been in addition to the medical visits to hospitals and GPs a significant number of journeys supporting social needs: to our lunch club, for people who could not otherwise have bought Christmas presents for loved ones, and such like. Such social journeys are often at least as important to people's well-being as their health needs.

Also so important for health and well-being is gentle exercise as people grow older, and the Tai Chi classes, run by Michelle Clifford and Matt Ward and managed by our President Jean Seagrim, have been hugely successful and expanded in number. Thanks go also to the United Reformed Church for this and much else, for making available their premises.

And to complete the well-being of the local residents is the Lunch Club, which Louise Kaiser has now been leading since September 2017, with a devoted band of helpers and pudding makers. It continues very popular, and the quality is as you would expect from the Kaisers! During the year they inaugurated a Pancake Day event on Shrove Tuesday, which was extremely well supported; we look forward to its repeat this year!

The Toenail cutting for which we teamed up with local clinician James Barber just over a year ago has also been very well received, not least as he does home visits which can be so difficult to arrange. This continues a good value service.

As with so many of our Clubs, the Wednesday Club has members who are increasingly elderly and with additional needs. This does create some concerns over health and safety issues, and indeed for safeguarding, where our volunteers may feel unprepared and wanting some training. So we have been updating our policies under the guidance of Hannah-Louise O'Callaghan, our new Secretary, and decided that we would benefit from some basic training on safeguarding and related issues. West Sussex County Council Adult Services have agreed to do this.

The First Tuesday Club, who are a knitting and social gathering, have also been very active during the year.

I mentioned earlier the welcome development of co-ordination of the huge range of voluntary effort in Pulborough. It is vital that people who are volunteering can feel connected and that needs and help offered are matched as far as possible, and unnecessary duplication reduced. The establishment of the Pulborough (and district) Voluntary Community Forum which is chaired by Liz Burt from Horsham District Council is much welcomed. It includes the local Churches as well as Voluntary organisations, and we hope it will expand to include more voluntary organisations. It also includes a link to the recent Social Prescribing initiative in the Pulborough Medical Group, where Freddie Jones has been playing a valuable role identifying people in need and referring them where appropriate. Social Prescribing is a national initiative to recognise and meet people's social needs alongside their health needs, and by improving their well-being reduce the need for medical interventions.

We also did our part in waving the flag for the P&DCCA at the Harvest Fair, at the West Chiltonington Show, and at the Duck Race, which is getting bigger from year to year. We will play our part in these again this year.

To raise our own profile more Ann Kaiser has been very helpfully doing work on a redesign of our logo and branding, and to make our leaflets more accessible.

I want to pay tribute to our former Treasurer Philip Migdale, who sadly passed away this year. He was a lovely man, very unassuming, and a huge support to the Association.

I wish also to give thanks to all our funders, including both Parish Councils, the Pulborough Medical Group, the support from District and County, the Co-Op, the Duck Race organisers, and the people who have made donations during the year, to enable us to continue.

I would like to thank our Committee Members, our former Secretary Sheila Moore who handed over so smoothly to our incoming Secretary Hannah-Louise O'Callaghan, and of course our President, Jean Seagrim, who celebrated her 90th year, with over 60 with the Association, and is still running several clubs! And especially our volunteers, who make all the effort to keep our services and clubs so efficient and welcoming for the residents of this community in the heart of Sussex.

Trustees Report for 2019

The Association is governed by its Constitution which was adopted on 22nd July 1985 and amended on 7th October 1991, 31st March 2003, 13th March 2013 and latterly on 23rd March 2015.

Our objects are:

- a. To promote the benefit of the elderly inhabitants of the area of benefit in any manner which is now or hereafter may be deemed to be charitable in law, and
- b. To relieve persons resident in the area of benefit who are in conditions of need, hardship or distress and to coordinate similar work undertaken in the said area by other voluntary organisations.

Trustees are appointed by the Committee and hold office for life or until discharged at their own request or by the Committee by resolution. We now also have an honorary President, Jean Seagrim, who was also our co-founder, and was appointed in March 2017.

Our activities during the year are reported on by their organisers elsewhere in this report.

Much of our funding is from local authorities, but we have funding from generous local organisations and from individuals who support what we do. We maintain a prudent level of reserves, given the current difficult economic climate and the uncertainty of a revenue stream.

During the year we have recruited an additional Trustee, Mike Clenshaw, who has been a stalwart of the organisation for many years. I am pleased to say that Sheila Moore, who retired this year as Honorary Secretary, continues as a Trustee. This means that we have four Trustees currently.

2019 was a busy and successful year for the Lunch Club. We continued to attract good attendance every week from our members and welcomed several new members throughout the year. Our current membership stands at 52 paying members.

During the year we celebrated a number of 'big' birthdays including one 99th and one 101st! We continue to provide one cooked meal each month, and were delighted to receive a grant of £740 from the WSCC microfund which enabled us to provide this service. In December we celebrated our Christmas Lunch and with donations received from the Rotary and Pentalpha Lodge we were able to give all 80 guests a complimentary meal.

We continued to work with Tesco and Fareshare and their weekly food donations together with other donations from the Parish Council and the Pulborough Pancake Day and the Waitrose Green token scheme meant that we ended our financial year in a healthy position.

There is a big support network that helps the Lunch Club to be a successful weekly club so special thanks goes to our 10 weekly volunteers at the Lunch Club, our 40 pudding makers, all the minibus drivers and escorts and to Rene Kaiser, our soup maker.

Pulborough Community Transport was very busy last year! In 2019, a total of 554 journeys were made. Currently 210 local residents are on the “active” database and we have a team of 33 drivers. In 2019, the Wheelchair Assisted Vehicle was used on 69 occasions, 35 to transport people to various medical appointments and 40 to transport people to the Lunch/Social Club or to other destinations such as Marks and Spencer at Shoreham to do some Christmas shopping or to Banks, Building Societies, Solicitors. The busiest month for all journeys undertaken was March with 62 but the quietest month was, surprisingly, December with only 25 journey requests. We are very rarely unable to provide transport providing at least 48 hours notice has been given.

Advertising for new drivers at the Pulborough Medical Group has been successful with two new drivers responding to this medium. Staff at PMG regularly give out to patients the PCT mobile phone number and quite a few new referrals to our service come through this way. Flyers have kindly been produced by Ann Kaiser and these are planned to be distributed regularly at the Lunch Club and also in The Hub which meets on a Monday morning in the Public Library. All in all, it is a service well received by residents and a life line for some who cannot access other forms of transport.

**MINUTES OF THE ANNUAL GENERAL MEETING held on
Monday 25th MARCH 2019 at 18:00 in

Members present: John Dixon (Chairman), Alan Sugarman (Treasurer), Sheila Moore (Secretary), Liz Sollom, Ann Kaiser, Jean Seagrim, Rosemary Russell, Helen Arbeid, Mike Clenshaw, Wendy Roberts, Jane Allison, Gerald Batt, Edna Henly, Jeanette Hicks & Christine Lindsay.

1. Welcome and Apologies for absence.

The Chairman extended a warm welcome to all members and guests attending the Annual General Meeting. He advised that under the Associations constitution, only members were eligible to propose, second and vote on any motion.

Apologies had been received from:

Nick Herbert MP, Cllr Paul Clarke, Rev Ann Lewitt, Freddie Jones, Vanessa Green, Michelle Clifford, Gwen Parr, Louise Kaiser and Stuart Henderson.

2. To approve the Minutes of the 2018 Annual General Meeting

The minutes of the 2018 AGM (held on Monday 12th March 2018) had been printed in this years Annual Report (from page 20 to page 25) and distributed at the meeting. There being no matters arising, it was proposed (by Alan Sugarman) and seconded (by Helen Arbeid), that they be approved. They were approved by members and duly signed by the Chairman.

3. To adopt the Annual Report and Accounts

The Chairman explained that the 2018 Annual Report had been produced and a copy left on each chair. Copies would later be sent out to many local supporters and other interested parties. The report summarises the various activities and services provided by PDCCA over the last year.

John explained that at the end of 2018 the organisation was generally in good shape although, yet again, there had been some significant changes. Generally the organisation was continuing to go from strength to strength.

Louise Kaiser took on as Lunch Club coordinator in September 2017 and has been very successfully running the Club throughout 2019.

Christine Lindsay took on responsibility for Community Transport as from January 2018 and has really taken the scheme forward, particularly with regards to the new IT system. Christine is hoping to increase the small number of social journeys that we are currently able to cover. This will require finding more volunteer drivers to cover the increasing demand for such journeys.

John also praised one of our volunteers, David Croxson, who runs the wheelchair accessible vehicle, saying that his work is much appreciated.

James Barber took over the running of our Toe Nail cutting service, which is working extremely well and is completely self-funding. His work is in great demand and is very much appreciated.

Despite all this good news, the organisation still needs help in some areas. Our Volunteer Visiting Scheme still needs one or more people to co-ordinate it. Without such help we are currently not taking on any new clients, although it is

recognised that loneliness is a serious and common problem in our current society. We will continue to actively look for someone to run this service through 2019.

The Good Neighbours Scheme also stumbled due, primarily, to the schemes very first organiser, Peter Jones, moving away from the area. The scheme is currently under the wings of the Community Wardens.

The Chairman wanted to thank the strong financial support we receive from the local Parish Councils (Pulborough & West Chiltington), Pulborough Medical Group and many other individual donations.

John restated the importance of linking up with other local services and told the meeting that we have been supported this year by Liz Burt, whose role at Horsham District Council is to coordinate the voluntary activities across the area. In addition, Freddie Jones is our local social prescriber, operating (partly) out of Pulborough Medical Group. His role covers prescribing social activities in the area to aid health and wellbeing.

Finally, the Chairman wanted to thank all the PDCCA committee members for all their efforts to maintain and grow services over this very challenging year. Sheila, who has been our secretary for the last 5 years, is leaving and will be replaced by Hannah-Louise O'Callaghan on 1st May.

Our **statement of financial activities** for the year ended 31st December 2018 had been printed, starting on page 15, in the Annual Report and distributed at the meeting, including the independent examiners report (page 18).

The treasurer, Alan Sugarman, stated that there is in fact a mistake in the report, on page 15. The amount shown for "Donations" should read £16,885, not £6,885 as shown.

There are also a couple of lines missing. The official Statement of financial activities which has been independently examined is correct, but it hasn't been fully reproduced in the final version of the Annual Report. This will be looked at and action taken to provide the proper figures.

He asked the meeting whether anyone had any questions about the financial report but there were none raised.

He then reported that, whilst there appears to be a healthy balance, we are still eating into our reserves each year and we need to keep busy to ensure a steady flow of income to continue to run all our services.

The chairman asked members to approve the Annual Report and the Accounts (with the necessary amendments) for 2018. These were proposed by Mike Clenshaw and seconded by Helen Arbeid and duly approved by members. Both the Annual Report and the Accounts will be lodged with the Charity Commission once the financial statement is properly reproduced and, as previously stated, will be made available to any interested parties.

4. To elect Officers and Committee for 2019

There are a number of people who have already or are about to step down from the committee this year. Sheila Moore will no longer be our secretary as from the end of April, but a replacement has been found. This will be Hannah-Louise O'Callaghan.

Helen Arbeid will no longer run our Sight Problems Group. Jean Seagrim advised that it is hoped that a new group is being set up in Storrington, which local people will be able to attend.

During the year Philip Migdale and Stuart Henderson stepped down and Jane Allison will not be standing again for 2019.

MONEY MATTERS:

How we are funded: The Pulborough & District Community Care Association is a registered charity. We receive grant funding from various bodies, including West Sussex County Council, Horsham District Council, Pulborough and West Chiltington Parish Councils, as well as legacies, sponsorship and donations from generous individuals and organisations in the community, including the Pulborough Medical Group, Harwoods and the Coop Local Community Fund. We also carry out regular fund-raising events.

We charge modest fees for most of our activities and services but these do not cover our full costs and we always welcome any extra help.

Donations & Gifts in Wills: If you would be prepared to pay more to use a service or would like to provide us with a one-off donation, we would be extremely grateful – just speak to the service organiser. If you are a tax payer, any contribution can be uplifted via Gift Aid. We are also introducing a “Friends of PDCCA” scheme, whereby volunteers, or anybody else who would like to support us, can make a regular small monthly contribution which would be very gratefully received & greatly help our efforts.
